AN ACT to provide for the service of the Republic of Seychelles for the year ending December 31st, 2018.

ENACTED by the President and the National Assembly.

1. This Act may be cited as the Appropriation Act, 2018.

Short title

Authorisation
of expenditure

2. The Minister of Finance, Trade and Economic Planning may by warrant under the hand of the Minister authorise the issue from the Consolidated Fund for the services of the Republic for the year 2018, a sum not exceeding seven billion nine hundred and thirty-five million, nine hundred and thirty seven thousand one hundred and ninety three (R7, 935,937,193) rupees which sum shall be appropriated in accordance with the Schedule for the purposes specified therein.
