## **GAZETTE REGULATIONS, 2020**

(SI 164 of 2020)

It is hereby notified for general information that under regulation 5 of the Gazette Regulations, 2020, the Attorney General has made the following determinations —

## Fees or Charges for publication in the Gazette

- 1. The fees or charges that a person shall pay for the publication of any statutory document, notice or advertisement in the Gazette is as follows
  - (a) The fees or charges of the notices and advertisement specified in the table per number of publication in the Gazette are as set out in the table —

## Fees and charges for the subscription to the Gazette

- **2.**(1) The fee for an annual subscription to the Gazette, excluding the supplement to the Gazette, in printed form is SCR4, 000.
- (2) A person shall pay the following fee or charge for an annual subscription of the supplement to the Gazette in printed form
  - (a) a deposit in the sum of SCR5,000; and
  - (b) the charge in paragraph 3 (b) for a supplement to the Gazette in printed form.
- (3) The annual fee for postage of the Gazette at any place on Mahe, Praslin and La Digue is SCR2,000 for an annual subscription to the Gazette and/or supplement to the Gazette.

- (4) The person shall pay the fees and charges under subparagraphs (1), (2) and (3) as follows
  - (a) SCR4,000 for the Gazette upon applying for the subscription to the Gazette;
  - (b) SCR5,000 for the supplement of the Gazette upon applying for the subscription to the supplement of the Gazette Supplement;
  - (c) in respect of subscription to the supplement to the Gazette, the charge under paragraph 2(2)(b) shall be paid out from the deposit made under paragraph 2(2)(a) and any additional charge shall be satisfied within 14 days of service of the invoice on the subscriber for the supplement to the Gazette;
  - (d) Where applicable, SCR2,000 for postage of the Gazette and/or the supplement to the Gazette upon applying for the subscription to the Gazette or the supplement to the Gazette; and
- (5) If upon service of the invoice for any supplement to the Gazette, the subscriber fails to satisfy the debt, the subscription to the supplement to the Gazette shall *ipso facto* terminate.

## Charge for a copy of the Gazette in printed form

- 3. The charge that a person shall pay to the Attorney General for any copy of the Gazette or the supplement to a Gazette in printed form shall be as follows
  - (a) SCR5.00 per page for the Gazette;
  - (b) SCR4.00 per page for any supplement to the Gazette.

## Subscription Fees for instant electronic notification of publication of a Gazette

- **4.** The following annual fees may be paid to the Attorney General in order to receive an instant notification to a designated email address every time a Gazette is published on the website
  - (a) SCR600 for a designated email address of a person, body corporate or an organization;
  - (b) SCR400 for each designated email address of a person, an organization or a body corporate who pays for the subscription of 2 or more email addresses;
  - (c) SCR200 for a designated email address of a person enrolled as a student at a recognized educational institution.

## Fees for the certification of a copy of Gazette

**5.**(1) The fees that a person shall pay for the certification of a copy of the

Gazette by the Attorney General or the Editor as a Gazette published under the authority of the Government shall be as follows —

- (a) SCR200 for the first stamp and certification affixed on a Gazette;
- (b) SCR50 for every additional stamp and certification required by the person and affixed on each Gazette;
- (2) No fee shall be charged to a person who has paid for the publication of a notice or advertisement in the Gazette for change of name under the Civil Status Act or a notice of intention to apply for citizenship of Seychelles under the Citizenship Act for the certification of up to 2 copies of the Gazette or any page thereof in which the notice or advertisement is published.

#### Commencement

6. These fees and charges come into effect from 1 January 2021.

## **PUBLIC HEALTH (AMENDMENT) ACT, 2021**

(Act 3 of 2021)

AN ACT to amend the Public Health Act, 2015 (Act 13 of 2015).

**ENACTED** by the President and the National Assembly.

#### **Short title**

1. This Act may be cited as the Public Health (Amendment) Act, 2021.

#### Amendment of section 26 of Act 13 of 2015

- **2.** Section 26(1) of the Public Health Act, 2015 (hereinafter referred to as the "principal Act") is amended
  - (a) in the chapeau, by repealing the words "introduction of infectious diseases into Seychelles" and substituting therefor "introduction of infectious diseases into Seychelles or spread of infectious diseases within Seychelles";
  - (b) in paragraph (d), by deleting the word "or";
  - (c) in paragraph (e), by replacing the full-stop at the end by a semi-colon;
  - (d) by inserting after paragraph (e), the following paragraph
    - "(f) the requirements of vaccination as a preventive measure to combat, control, treat and prevent the spread of infectious diseases and authorising the use of such vaccines in emergency situations.".

## Amendment of section 64 of Act 13 of 2015

- 3. Section 64 of the principal Act is amended by inserting after paragraph (n), the following paragraphs
  - "(na) the creation of offences and imposition of penalties not exceeding a fine of SCR50,000 or imprisonment for a term not exceeding 2 years or both;
  - (nb) the imposition of a fixed penalty in respect of any offence, and authorise one or more public officers for such purpose;

(nc) specifying that the payment of a fixed penalty may discharge the person of liability from prosecution for an offence;".
