### 1. Citation

These Regulations may be cited as the Customs Management (Levy on Importation of Motor Vehicles for Taxi Operators' Business) Regulations, 2012.<sup>\*</sup>

#### 2. Levy

- (1) Motor vehicles imported for the purpose of carrying the business of taxi operators shall be subject to a levy of SCR5,000.
- (2) An application for the payment of the levy referred to in paragraph (1) shall be made to the Ministry responsible for Trade accompanied by a Bill of Entry endorsed by an authorised officer in the Ministry of Finance.

Note: The reference to 2012 appears to be a typographical error in the short title as these Regulations were gazetted as SI 25 of 2013.
