

S.I. 75 of 2013**PUBLIC UTILITIES CORPORATION ACT***(Cap 196)***Water Supply (Treated Water) (Charges) (Amendment) Regulations, 2013**

In exercise of the powers conferred by section 17 of the Public Utilities Corporation Act, the Minister of Environment and Energy makes the following Regulations—

1. These Regulations may be cited as the Water Supply (Treated Water) (Charges) (Amendment) Regulations, 2013 and shall come into force on 1st November, 2013.

Citation and commencement

2. The Water Supply (Treated Water) (Charges) Regulations, 1994 are amended by repealing the Schedule and substituting therefor the following Schedule—
