**Legal Practitioners (Licence Application Form) Regulations, 2014**

In exercise of the powers conferred by section 22 (1) (b) read with section 6A (1) and (3) of the Legal Practitioners Act, the President being the Minister responsible for Legal Affairs hereby makes the following Regulations —

Citation

**1.** These regulations may be cited as the Legal Practitioners (Licence Application Form) Regulations, 2014.

Form for application

**2.** An application for a legal practitioner's license or for the renewal of a legal practitioner's license under section 6A(1) shall be made in the Forms provided under the First Schedule.

Form of certificate

**3.** A legal practitioner's license shall be issued in the Form as provided under the Second Schedule.

Form of Register

**4.** The Registrar shall keep or cause to be kept a register of legal practitioner's license issued under section 6A(3) of this Act, in the Form as provided in the Third Schedule.
