PUBLIC SERVICE SPECIAL PENSION ACT, 2017

(Act 24 of 2017)

**Public Service Special Pension (Life Certificate)
(Amendment) Regulations, 2019**

In exercise of the powers conferred by section 10 (1) read with section 10(3) of the Public Service Special Pension Act, 2017, the President acting as the Minister for Public Administration makes the following regulations —

1. These regulations may be cited as the Public Service Special Pension (Life Certificate) (Amendment), Regulations, 2019 and shall be deemed to have come into operation on 25th March, 2019.

Citation

2. The Public Service Special Pension (Life Certificate) Regulations, 2017, is amended as follows —

Amendment of

- (a) in Part 2, under the Schedule, by repealing the words starting with “the home carer of the pensioner” and ending with the words “**delete what is inapplicable”;
- (b) after Part 2, by inserting the following parts —
