3.(1) Any person who physically transports, mails or ships or causes to be physically transported, mailed or shipped, to or from Seychelles, cash in an aggregate sum of SCR50,000 or more shall make a declaration to the Customs Division with the details mentioned in the Declaration Form specified in the Schedule to these regulations.

- (2) In pursuance of section 75 (2) of the Act, if a person —

1. These regulations may be cited as the Prevention of Terrorism (Implementation of United Nations Security Council Resolutions on Suppression of Terrorism) (Amendment) Regulations, 2022.

**Amendments to S.I. 39 of 2015**

2. The Prevention of Terrorism (Implementation of United Nations Security Council Resolutions on Suppression of Terrorism) Regulations are amended as follows —

- (a) regulation 2 is amended by inserting after serial number (23) and definition thereon, the following serial number and definition —

“(23A) “Resolution 2231” means Resolution 2231 (2015) of the Security Council and includes all its successor resolutions;”;

- (b) regulation 5(1)(a) is amended by repealing the words “and 1988” and therefor substituting the words “,1988 and 2231”;

- (c) regulation 6 (5) is amended by repealing the words “without any delay” and therefor substituting the words “within 24 hours”;
- (d) by repealing regulation 8 and therefor substituting the following regulation —

“8.(1) The Financial Intelligence Unit shall access the United Nations Security Council website on every working day to verify as to whether there have been any updates to the relevant United Nations Security Council Consolidated List.

(2) Whenever there are updates, the Financial Intelligence Unit shall immediately disseminate the updated list to —

- (a) the Ministry for Internal Affairs and the Committee for updation of the Seychelles list under regulation 11(1);
- (b) all supervisory authorities;
- (c) all law enforcement agencies; and
- (d) such other relevant authorities as the Financial Intelligence Unit may consider necessary;

(3) Whenever there are deletion of the names of the designated entities in the Seychelles List under regulation 12(6) and circulation of notice under regulation 12(7), the Financial Intelligence Unit shall immediately disseminate the list and circulate the updated list to the entities specified in subregulation (2)(b), (c) and (d).

(4) The entities referred to in paragraphs (b) to (d) of sub-regulation (2) shall, immediately upon receipt of the list disseminated to it under sub regulation (2) —

- (a) circulate the list to all the entities under its purview for their information and to take necessary actions in pursuance of section 35 of the Act;
  - (b) wherever necessary, provide guidance to the entities holding property of a listed entity or individual, to comply with their obligations under these regulations and the Act; and
  - (c) ensure the compliance with the requirements of these regulations.”;
- (e) regulation 11 is amended by repealing subregulation (5) and therefor substituting the following sub-regulation —
- “(5) When the Seychelles list is updated —
- (a) the Secretary to the Committee shall immediately cause the updated Seychelles list to be published on the website of the competent authorities;
  - (b) the Ministry responsible for foreign affairs shall submit the updated Seychelles list to the relevant Sanctions Committee and countries.”;
- (f) regulation 12 (7) is amended by repealing the words “regulation 8(4)” and therefor substituting the words “regulation 8(3)”;

1. These regulations may be cited as the Prevention of Proliferation Financing (Amendment) Regulations, 2022.

**Amendments to S.I. 21 of 2021**

2. The Prevention of Proliferation Financing Regulations, 2021 are amended as follows —

(a) in regulation 4 —

(i) in subregulation (4), repeal the word “annually” and therefor substitute the words “as and when necessary”;

(ii) after subregulation (6), the following subregulations shall be added —

“(6A) The Committee shall seek required approvals at all stages from the relevant United Nations Sanctions Committee before making any recommendation to the Attorney General for the deletion of the name of the entity appearing on the sanctions list.

(6B) Upon receipt of an application under subregulations (3) or (5), after the verification of

identity documentation and other information, if the Attorney General or the Committee establishes that the party is not the actual designated party or listed party, it shall —

- (a) where the application relates to the United Nations Consolidated List, submit the request to the United Nations Sanctions Committee for determination, and upon receipt of feedback, the Attorney General or the Committee shall inform the applicant of the decision taken;
- (b) assess the application and make a determination and inform the applicant of the decision not later than fifteen working days from the date of receipt of the application.”;

(iii) by repealing subregulations (10) and 11;

- (b) after regulation 4, the following regulation shall be added —

**“Application for delisting by the Focal Point of the United Nations Secretariat**

4A. Notwithstanding anything in regulation 4, a listed party may submit a request for delisting directly to the Focal Point established within the United Nations Secretariat under the United Nations Security Council Resolution 1730.”;

- (c) in regulation 5 —

(i) in subregulation (2), repeal the words “make an application” and therefor substitute the words “submit an application along with necessary documents and information to substantiate the grounds in the

application”;

- (ii) after subregulation (3), the following proviso shall be added —

“Provided that when the Committee proposes to determine that the funds or other property are to be allowed for the purposes specified in regulation 5(2), the Committee shall notify the relevant United Nations Sanctions Committee at all stages of its verification and the Committee shall also communicate to the United Nations Sanctions Committee about its opinion on the release or otherwise of the funds or other property.”;

- (iii) after subregulation (3), the following subregulation shall be added —

“(3A) The Committee shall notify the listed party of the decision of the United Nations Sanctions Committee for the use of the funds or other assets, or any part thereof, for ordinary or extraordinary expenses.

Provided that for ordinary expenses, in the absence of a decision within the 5 working days of the notification under proviso to subregulation (3), it shall be deemed that the relevant United Nations Sanctions Committee has not objected to the use of the funds or other assets.”.

In exercise of the powers conferred by section 75(1) read with section 97 of the Anti-Money Laundering and Countering the Financing of Terrorism Act, 2020 (Act 5 of 2020), the Minister responsible for Finance makes the following regulations —

**Citation**

1. These regulations may be cited as the Anti-Money Laundering and Countering the Financing of Terrorism (Cross Border Declaration) Regulations, 2022.

**Definitions**

2. In these regulations, unless the context otherwise requires —

“Act” means the Anti-Money Laundering and Countering the Financing of Terrorism Act, 2020 (Act 5 of 2020);

“cash” shall have the same meaning assigned to it in the Act;

“courier” means a person or company that takes messages, letters or parcels from a person or place to another person or place.

**Cross border declaration**

3.(1) Any person who physically transports, mails or ships or causes to be physically transported, mailed or shipped, to or from Seychelles, cash in an aggregate sum of SCR50,000 or more shall make a declaration to the Customs Division with the details mentioned in the Declaration Form specified in the Schedule to these regulations.

- (2) In pursuance of section 75 (2) of the Act, if a person —
- (a) fails to make a declaration under subregulation (1); or
  - (b) knowingly makes a declaration under subsection (1) which is false or misleading,

commits an offence and shall be liable on conviction to a fine provided under section 75(2) of the Act.

(3) Provisions of subregulation (1) shall not apply to the Central Bank of Seychelles.

**Citation**

1. These regulations may be cited as the Prevention of Terrorism (Implementation of United Nations Security Council Resolutions on Suppression of Terrorism) (Amendment) Regulations, 2022.

**Amendments to S.I. 39 of 2015**

2. The Prevention of Terrorism (Implementation of United Nations Security Council Resolutions on Suppression of Terrorism) Regulations are amended as follows —

- (a) regulation 2 is amended by inserting after serial number (23) and definition thereon, the following serial number and definition —

“(23A) “Resolution 2231” means Resolution 2231 (2015) of the Security Council and includes all its successor resolutions;”;

- (b) regulation 5(1)(a) is amended by repealing the words “and 1988” and therefor substituting the words “,1988 and 2231”;

- (c) regulation 6 (5) is amended by repealing the words “without any delay” and therefor substituting the words “within 24 hours”;
- (d) by repealing regulation 8 and therefor substituting the following regulation —

“8.(1) The Financial Intelligence Unit shall access the United Nations Security Council website on every working day to verify as to whether there have been any updates to the relevant United Nations Security Council Consolidated List.

(2) Whenever there are updates, the Financial Intelligence Unit shall immediately disseminate the updated list to —

- (a) the Ministry for Internal Affairs and the Committee for updation of the Seychelles list under regulation 11(1);
- (b) all supervisory authorities;
- (c) all law enforcement agencies; and
- (d) such other relevant authorities as the Financial Intelligence Unit may consider necessary;

(3) Whenever there are deletion of the names of the designated entities in the Seychelles List under regulation 12(6) and circulation of notice under regulation 12(7), the Financial Intelligence Unit shall immediately disseminate the list and circulate the updated list to the entities specified in subregulation (2)(b), (c) and (d).

(4) The entities referred to in paragraphs (b) to (d) of sub-regulation (2) shall, immediately upon receipt of the list disseminated to it under sub regulation (2) —

- (a) circulate the list to all the entities under its purview for their information and to take necessary actions in pursuance of section 35 of the Act;
  - (b) wherever necessary, provide guidance to the entities holding property of a listed entity or individual, to comply with their obligations under these regulations and the Act; and
  - (c) ensure the compliance with the requirements of these regulations.”;
- (e) regulation 11 is amended by repealing subregulation (5) and therefor substituting the following sub-regulation —
- “(5) When the Seychelles list is updated —
- (a) the Secretary to the Committee shall immediately cause the updated Seychelles list to be published on the website of the competent authorities;
  - (b) the Ministry responsible for foreign affairs shall submit the updated Seychelles list to the relevant Sanctions Committee and countries.”;
- (f) regulation 12 (7) is amended by repealing the words “regulation 8(4)” and therefor substituting the words “regulation 8(3)”;
- (g) regulation 13 (1A) is amended by repealing the words “without any delay and prior notice” and therefor substituting the words “within 24 hours and without any prior notice”;
- (h) regulation 14(2)(c) is amended by repealing the words “and 1988” and therefor substituting the words “, 1988 and 2231”;

## PREVENTION OF TERRORISM ACT

*(Act 7 of 2004)***Prevention of Proliferation Financing (Amendment) Regulations, 2022**

In exercise of the powers conferred by section 20E of the Prevention of Terrorism Act, 2004 (Cap. 179), the Minister responsible for Internal Affairs makes the following regulations —

**Citation**

1. These regulations may be cited as the Prevention of Proliferation Financing (Amendment) Regulations, 2022.

**Amendments to S.I. 21 of 2021**

2. The Prevention of Proliferation Financing Regulations, 2021 are amended as follows —

(a) in regulation 4 —

(i) in subregulation (4), repeal the word “annually” and therefor substitute the words “as and when necessary”;

(ii) after subregulation (6), the following subregulations shall be added —

“(6A) The Committee shall seek required approvals at all stages from the relevant United Nations Sanctions Committee before making any recommendation to the Attorney General for the deletion of the name of the entity appearing on the sanctions list.

(6B) Upon receipt of an application under subregulations (3) or (5), after the verification of

identity documentation and other information, if the Attorney General or the Committee establishes that the party is not the actual designated party or listed party, it shall —

- (a) where the application relates to the United Nations Consolidated List, submit the request to the United Nations Sanctions Committee for determination, and upon receipt of feedback, the Attorney General or the Committee shall inform the applicant of the decision taken;
- (b) assess the application and make a determination and inform the applicant of the decision not later than fifteen working days from the date of receipt of the application.”;

(iii) by repealing subregulations (10) and 11;

- (b) after regulation 4, the following regulation shall be added —

**“Application for delisting by the Focal Point of the United Nations Secretariat**

4A. Notwithstanding anything in regulation 4, a listed party may submit a request for delisting directly to the Focal Point established within the United Nations Secretariat under the United Nations Security Council Resolution 1730.”;

- (c) in regulation 5 —

(i) in subregulation (2), repeal the words “make an application” and therefor substitute the words “submit an application along with necessary documents and information to substantiate the grounds in the

application”;

- (ii) after subregulation (3), the following proviso shall be added —

“Provided that when the Committee proposes to determine that the funds or other property are to be allowed for the purposes specified in regulation 5(2), the Committee shall notify the relevant United Nations Sanctions Committee at all stages of its verification and the Committee shall also communicate to the United Nations Sanctions Committee about its opinion on the release or otherwise of the funds or other property.”;

- (iii) after subregulation (3), the following subregulation shall be added —

“(3A) The Committee shall notify the listed party of the decision of the United Nations Sanctions Committee for the use of the funds or other assets, or any part thereof, for ordinary or extraordinary expenses.

Provided that for ordinary expenses, in the absence of a decision within the 5 working days of the notification under proviso to subregulation (3), it shall be deemed that the relevant United Nations Sanctions Committee has not objected to the use of the funds or other assets.”.
