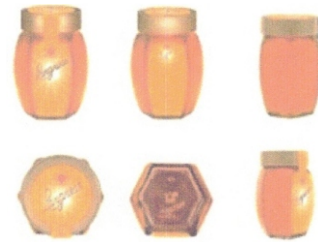

1. This Order may be cited as the International Monetary Fund-Extended Fund Facility Debt Order, 2024.

Loan Agreement

2. The Minister responsible for financial matters has in accordance with section 4 of the Public Debt Management Act, entered into an extended three-year arrangement for and on behalf of the Republic of Seychelles with the International Monetary Fund under the Extended Fund Facility(EFF).

Particulars

3. The particulars of the arrangement referred to in paragraph 2 are as follows —

- (a) in regulation 2, by repealing the word “may” and substituting the word “shall”;
- (b) by renumbering regulation 3 as regulation “3.(1)” and inserting after subregulation (1) the following —

“(2) Notwithstanding subregulation (1), the Commissioner General may payout refund in the absence of a claim when satisfied that the taxpayers account is in order.”.

2. The Fourth Schedule of the Value Added Tax Act is repealed and substituted with the following —

**“Fourth Schedule
Registration threshold**

- (a) The registration threshold for the purposes of section 7 is SCR2,000,000.
- (b) The registration threshold for the purposes of section 9 of the Value Added Tax Act is SCR100,000.”.
