### Road (Authorisation) Order, 2017

WHEREAS the land described in the Schedule (herein after referred to as "the land") was part of the Nouvelle Decouverte Road at Grand Anse, Praslin which belonged to Mr. Joseph Albert;

AND WHEREAS the said land is no longer required for use as a thoroughfare by the general public;

AND WHEREAS Mr. Joseph Albert has in consideration for giving possession of the said land, agreed to construct a new road by act of a verbal/gentlemen's agreement with the Government in July, 1997.

AND WHEREAS a Committee of Inquiry as required by section 7 of the Road Act was constituted and the matter was referred to the Committee;

AND WHEREAS the Committee has complied with all the formalities required under the Road Act and submitted its report to the Government;

AND WHEREAS a notice of enquiry was published in the local newspaper (NATION) and in the Gazette on 25th April, 2016.

AND WHEREAS no objections to the proposed authorisation have been received;

THEREFORE, in exercise of the powers conferred by section 13 read with section 6 of the Road Act, the Minister of Habitat, Infrastructure and Land Transport hereby authorises Mr. Joseph Albert, to take possession of the land.

The portion of the Nouvelle Decouverte, road measures approximately 363 metres long and 6 metres wide and is situated on the backshore of parcels PR2712, PR1717 and PR2935.
