1. This order may be cited as the 12% 7 year Solidarity Citation Bond Order, 2020.

2. The Minister responsible for financial matters has in accordance with the provisions of section 8 read with section 9 of the Public Debt Management Act, raised a local debt by issuance of a bond for and on behalf of the Government of Seychelles, the particulars of which are stated in paragraph 3.

3. The particulars of the Bond referred to in paragraph 2 Particulars are as follows —

(a)	Amount of the Bond:	SCR500,000,000 (Seychelles Rupees Five Hundred million only);
` ´	Purpose of the facility:	For Fiscal Policy purposes;
(c)	Persons subscribing:	Adult individuals (single or jointly), commercial banks, corporate bodies, institutions, clubs, societies and other organisations, in all cases to both resident and non- resident;
