In exercise of the powers conferred by article 107 of the Constitution of the Republic of Seychelles, the President hereby makes the following Proclamation —

1. This Proclamation may be cited as the Constitution of Seychelles (First Meeting of the National Assembly) Proclamation, 2020.

Citation
