Income and Non-Monetary Benefits Tax (Amendment of Second Schedule) Regulations, 2021

Citation

1. These regulations may be cited as the Income and Non-Monetary Benefits Tax (Amendment of Second Schedule) Regulations, 2021.

Amendment of Second Schedule as last amended by S.I. 70 of 2019

- 2. The Second Schedule to the Income and Non-Monetary Benefits Tax Act is hereby amended in paragraph 1 by inserting after sub paragraph (p), the following sub paragraph
 - "(q) a monthly or lump sum payment received by a beneficiary of a private pension fund or a pension scheme, being a pension fund or a pension scheme established by an employer where contributions are made by the employer on behalf of the employed person.".

FISHERIES ACT

(Act 20 of 2014)

Fisheries (Mahé Plateau Trap and Line Fishery) Regulations, 2021

In the exercise of the powers conferred by sections 6 and 77 of the Fisheries Act, 2014, the Minister of Fisheries and the Blue Economy hereby makes the following Regulations —

PART I - PRELIMINARY

Citation and commencement

1. These Regulations may be cited as the Fisheries (Mahé Plateau Trap and Line Fishery) Regulations, 2021 and shall come into operation on such date as the Minister may by Notice in the Gazette appoint.

Objectives

2. The objective of these Regulations is to implement the Seychelles Mahé Plateau Trap and Line Fishery Co-management Plan, published in Government Notice No. 68 of 2020, and pursuant to the Fisheries Act, 2014 section 5(4) which permits the Authority to enter into co-management arrangements for the management of a fishery and section 6(1) which empowers the Minister to make regulations prescribing measures for the proper management of a fishery.

Interpretation

- 3. In these Regulations the terms used shall have the same meaning given in section 3 of the Fisheries Act, 2014 as may be amended or replaced, and in addition for the purposes of these Regulations and unless otherwise provided or the context otherwise requires
 - "Act" when expressed as "this Act" or "the Act", means the Fisheries Act, 2014, and may, unless the context otherwise requires, be understood to include requirements or provisions in

any subsidiary instrument made thereunder having the force of law;

"Authority" means the Authority established by the Seychelles Fishing Authority (Establishment) Act 1984 (Cap 214);

"bag limit" refers to the maximum number of fish permitted;

"buy" or "purchase" includes —

- (a) barter or attempt to barter;
- (b) purchase or attempt to purchase;
- (c) trade or attempt to trade;
- (d) receive on account or consignment; or
- (e) receive in order to send, forward or deliver for sale;

"commercial fishing vessel" means a vessel, other than a sport fishing vessel, recreational fishing vessel or other type of vessel subject to these regulations, that holds a valid and applicable licence and is used for fishing for purposes of obtaining commercial gain from the catch and "commercial fisher or fishery" shall have a similar meaning;

"fork length" means —

- (a) where fish have caudal fins and it is difficult to establish where the vertebral column ends, the length of the fish measured from the tip of the snout to the end of the middle caudal fin rays; or
- (b) where the fish have tails with a fork shape, the length of the fish measured from the tip of the snout to the fork of the tail;

[&]quot;land" means to off load the fish from the boat to the land or a land-based facility;

"operator" means any person who is in charge of, responsible for the operations of, directs or controls a vessel, including the owner, charterer, master and the beneficiary of the economic or financial benefit of the vessel's operations;

"Performance Monitoring System" means the system described in Regulation 14;

"primary stakeholders" means are those that benefit directly from or are adversely affected by actions of these regulations, may be wholly dependent on the fishery resource or related services for their well-being and have few other options when faced with change;

"recreational fishing" means any fishing activity carried out primarily for purposes of leisure or hobby which does not involve any commercial disposition of the fish caught including trading, buying or selling, and "recreational fisher" and "recreational fishing vessel" shall have a similar meaning;

"sell" includes —

- (a) any method of disposition for consideration, including cash, trade and barter, of anything which has value or which can be exchanged for cash;
- (b) disposition to an agent for sale on consignment;

Bag limits

 - (b) retain onboard, tranship or land fish that exceed such bag limits or attempt any such activities.

Requirements and limitations for use, etc of traps

 - (a) it has been registered in accordance with procedures publicly notified by the Authority; and
 - (b) a licence for the use of the trap has been issued by the Authority.
- (2) No person, being a fisher or a vessel operator or other person who assists or is associated with the catching of fish or otherwise, shall deploy, maintain, recover or otherwise use or attempt to use a trap, including for commercial, recreational or sport purposes, except in full compliance with the limitations in the Third Schedule and as applicable in the area defined in the Fourth Schedule.

Exemptions

9. The Authority may exempt any person from the requirements of Regulations 5, 6, 7 or 8 for purposes of research, aquaculture or other stated purposes with the aim of supporting the objective of these regulations.

Statistics and information

10. Any person involved in activities regulated under these regulations shall provide the Authority with all such reports and information in relation to the activities that the Authority may require.

Vessel monitoring system

11. Any vessel operator carrying out activities regulated under these regulations shall comply with all monitoring and surveillance conditions that the Authority may require, including those relating to vessel monitoring systems.

PART III - SALE, PURCHASE, EXPORT ETC OF FISH

Sales of fish by recreational or sport fishers prohibited

12. No person shall purchase or sell fish that was caught in any recreational fishing, competition sport fishing or sport fishing activity unless exempted in writing by the Authority.

Purchase of fish from licensed fishers only

13. No person shall purchase fish unless it was caught by a license holder in a commercial fishery and in compliance with these Regulations.

PART IV - INSTITUTIONAL ARRANGEMENTS

Committee established to oversee management of the Mahe Plateau trap and line fishery

14.(1) An Implementation Committee (hereafter "Committee") is hereby established to oversee the implementation of the Mahé Plateau Trap and Line Fishery Management Plan (hereafter "Management Plan") and review future developments.

- (2) The Committee shall report on and make recommendations to the Minister responsible for Fisheries in relation to the implementation of Management Plan, including issues relating to day-to-day management, education, awareness and enforcement.
- (3) The reports and recommendations of the Committee shall be based on the Performance Monitoring System, and shall include compliance, updates on the status of fish stocks, changes to regulations and the performance of the education awareness strategies.
- (4) The Committee shall be comprised fourteen (14) voting members split equally between primary and secondary stakeholders.
- (5) Observers, comprised of primary and secondary stakeholders, may participate without vote in the meetings of the Committee.
- (6) The Committee shall meet at least once every 3 months and make publicly available on the website of the Authority or by other agreed means an update on the progress of implementation of the Management Plan and other relevant information and reports.
 - (7) The Committee shall adopt its own Rules of Procedure.
- (8) The Authority shall provide administrative support to the Implementation Committee and provide reports on the Performance Monitoring System, fish stocks status, compliance and other matters as requested.

PART V - OFFENCES, FINES AND PENALTIES

Offences and fines

- **15.**(1) Any person who contravenes these regulations, including regulations 5(1) (a) and (b), 6 (a) and (b), 7 (a) and (b), 8(1)(a) and (b), 8(2), 9, 10, 11, 12 and 13, commits an offence and on conviction, shall be liable to a fine not exceeding SCR20,000.

EXPLANATORY STATEMENT OF THE OBJECTS OF AND REASONS FOR THE BILL

The President of the Republic, in his address to the Nation on 1 February, 2021 announced the restructuring of Government, statutory and other public bodies.

It was proposed that the function of the Public Persons (Declaration of Assets, Liabilities and Business Interests) Commissioner under this Act be entrusted to the Anti-Corruption Commission.

In consequence of the appointment of Commissioner under the Anti-Corruption Act, 2016, as amended by the Anti-Corruption (Amendment) Act, 2021, and to give effect to the said announcement, it is proposed to entrust the function of Public Persons (Declaration of Assets, Liabilities and Business Interests) Commissioner under this Act to the Commissioner to the Anti-Corruption Commission.

The Bill also seeks to —

- (a) remove the obligation of a public person to submit declaration in relation to his or her spouse and a member of his or her immediate family; and
- (b) make provision for the Commissioner to establish and maintain a secure electronic system for submission of declarations and matters relating thereto.

In consequence of the above, it is proposed to amend sections 2, 3, 8 and 20 of the Act, repeal sections 4 and 5 and Part IV of the Act and provide for other consequential provisions.

The Bill seeks to achieve the above objectives.

This Act may be cited as the Public Persons (Declaration of Assets, Liabilities and Business Interests (Amendment) Act, 2021, and shall be read and construed as one with the Public Persons (Declaration of Assets, Liabilities and Business Interests Act, 2016 (Act 26 of 2016), that was last amended by Act 3 of 2019, and which as amended, is hereinafter referred to as the "principal Act".

Commencement

2. This Act shall come into operation on such date as the Minister may, by Notice published in the *Gazette*, appoint.

Fisheries (Mahé Plateau Trap and Line Fishery) Regulations, 2021

In the exercise of the powers conferred by sections 6 and 77 of the Fisheries Act, 2014, the Minister of Fisheries and the Blue Economy hereby makes the following Regulations —

PART I - PRELIMINARY

Citation and commencement

- (2) No person, being a fisher or a vessel operator or other person who assists or is associated with the catching of fish or otherwise, shall deploy, maintain, recover or otherwise use or attempt to use a trap, including for commercial, recreational or sport purposes, except in full compliance with the limitations in the Third Schedule and as applicable in the area defined in the Fourth Schedule.

Exemptions

9. The Authority may exempt any person from the requirements of Regulations 5, 6, 7 or 8 for purposes of research, aquaculture or other stated purposes with the aim of supporting the objective of these regulations.

Statistics and information

10. Any person involved in activities regulated under these regulations shall provide the Authority with all such reports and information in relation to the activities that the Authority may require.

Vessel monitoring system

11. Any vessel operator carrying out activities regulated under these regulations shall comply with all monitoring and surveillance conditions that the Authority may require, including those relating to vessel monitoring systems.

PART III - SALE, PURCHASE, EXPORT ETC OF FISH

Sales of fish by recreational or sport fishers prohibited

12. No person shall purchase or sell fish that was caught in any recreational fishing, competition sport fishing or sport fishing activity unless exempted in writing by the Authority.

Purchase of fish from licensed fishers only

13. No person shall purchase fish unless it was caught by a license holder in a commercial fishery and in compliance with these Regulations.

PART IV - INSTITUTIONAL ARRANGEMENTS

Committee established to oversee management of the Mahe Plateau trap and line fishery

14.(1) An Implementation Committee (hereafter "Committee") is hereby established to oversee the implementation of the Mahé Plateau Trap and Line Fishery Management Plan (hereafter "Management Plan") and review future developments.

- (2) The Committee shall report on and make recommendations to the Minister responsible for Fisheries in relation to the implementation of Management Plan, including issues relating to day-to-day management, education, awareness and enforcement.
- (3) The reports and recommendations of the Committee shall be based on the Performance Monitoring System, and shall include compliance, updates on the status of fish stocks, changes to regulations and the performance of the education awareness strategies.
- (4) The Committee shall be comprised fourteen (14) voting members split equally between primary and secondary stakeholders.
- (5) Observers, comprised of primary and secondary stakeholders, may participate without vote in the meetings of the Committee.
- (6) The Committee shall meet at least once every 3 months and make publicly available on the website of the Authority or by other agreed means an update on the progress of implementation of the Management Plan and other relevant information and reports.
 - (7) The Committee shall adopt its own Rules of Procedure.
- (8) The Authority shall provide administrative support to the Implementation Committee and provide reports on the Performance Monitoring System, fish stocks status, compliance and other matters as requested.

PART V - OFFENCES, FINES AND PENALTIES

Offences and fines

- **15.**(1) Any person who contravenes these regulations, including regulations 5(1) (a) and (b), 6 (a) and (b), 7 (a) and (b), 8(1)(a) and (b), 8(2), 9, 10, 11, 12 and 13, commits an offence and on conviction, shall be liable to a fine not exceeding SCR20,000.
- (2) Any person who does not comply with an exemption issued under regulation 9 commits an offence.

Income and Non-Monetary Benefits Tax (Amendment of Second Schedule) Regulations, 2021

1. These regulations may be cited as the Income and Non-Monetary Benefits Tax (Amendment of Second Schedule) Regulations, 2021.

Amendment of Second Schedule as last amended by S.I. 70 of 2019

- 2. The Second Schedule to the Income and Non-Monetary Benefits Tax Act is hereby amended in paragraph 1 by inserting after sub paragraph (p), the following sub paragraph
 - "(q) a monthly or lump sum payment received by a beneficiary of a private pension fund or a pension scheme, being a pension fund or a pension scheme established by an employer where contributions are made by the employer on behalf of the employed person.".

PUBLIC PERSONS (DECLARATION OF ASSETS, LIABILITIES AND BUSINESS INTERESTS) (AMENDMENT) BILL, 2021

(Bill No. 41 of 2021)

EXPLANATORY STATEMENT OF THE OBJECTS OF AND REASONS FOR THE BILL

The President of the Republic, in his address to the Nation on 1 February, 2021 announced the restructuring of Government, statutory and other public bodies.

It was proposed that the function of the Public Persons (Declaration of Assets, Liabilities and Business Interests) Commissioner under this Act be entrusted to the Anti-Corruption Commission.

In consequence of the appointment of Commissioner under the Anti-Corruption Act, 2016, as amended by the Anti-Corruption (Amendment) Act, 2021, and to give effect to the said announcement, it is proposed to entrust the function of Public Persons (Declaration of Assets, Liabilities and Business Interests) Commissioner under this Act to the Commissioner to the Anti-Corruption Commission.

The Bill also seeks to —

- (a) remove the obligation of a public person to submit declaration in relation to his or her spouse and a member of his or her immediate family; and
- (b) make provision for the Commissioner to establish and maintain a secure electronic system for submission of declarations and matters relating thereto.

In consequence of the above, it is proposed to amend sections 2, 3, 8 and 20 of the Act, repeal sections 4 and 5 and Part IV of the Act and provide for other consequential provisions.

The Bill seeks to achieve the above objectives.

AN ACT to amend the Public Persons (Declarations of Assets, Liabilities and Business Interests Act (Act 26 of 2016).

ENACTED by the President and the National Assembly.

Short title and amendment of Act 26 of 2016 as last amended by Act 3 of 2019

1. This Act may be cited as the Public Persons (Declaration of Assets, Liabilities and Business Interests (Amendment) Act, 2021, and shall be read and construed as one with the Public Persons (Declaration of Assets, Liabilities and Business Interests Act, 2016 (Act 26 of 2016), that was last amended by Act 3 of 2019, and which as amended, is hereinafter referred to as the "principal Act".

Commencement

2. This Act shall come into operation on such date as the Minister may, by Notice published in the *Gazette*, appoint.

Amendment of section 2

- 3. Section 2 of the principal Act is amended —
- (a) by repealing in the definition of "liabilities" the words ", his or her spouse or member of his or her immediate family,", wherever they appear throughout the definition.
 - (b) by repealing the definition of "member of immediate family".

Amendment of section 3

- **4.** Section 3 of the principal Act is amended as follows
 - (a) by repealing subsections (3) and (4);
 - (b) by inserting immediately after subsection (2) a new subsection (3)
 - "(3) The function of Commissioner under this Act shall be performed and discharged by the Commissioner to the Anti-Corruption Commission appointed under section 6 of the Anti-Corruption Act, 2016 (Act 2 of 2016)."

Repeal of sections 4 and 5

5. The principal Act is amended by repealing sections 4 and 5.

Insertion of a new section 7A

6. The principal Act is amended by inserting a new section 7A as follows —

"Submission of electronic declaration

- **7A.**(1) This section shall apply notwithstanding anything to the contrary contained in this Act;
 - (2) The Commissioner may establish and maintain a secure electronic systemand make provision for
 - (a) a public person to complete, sign and submit a
 declaration under this Act by electronic means
 that shall be exclusive, or in the alternative or in
 addition to the submission of declaration in
 printed form;
 - (b) the Commissioner to acknowledge receipt of electronic submission of a declaration;
 - (c) a public person to electronically access his or her declaration;
 - (d) a person applying to access declarations, to apply for and access declarations by remote electronic means;
 - (e) such other matters relating to electronic submission of declarations, authentications thereof and access thereto;
- (3) Where a public person submits his or her declaration by electronic means, the Commissioner shall give the public person a copy of the declaration in printed form for his or her personal record or a secure means to electronically access his or her declaration on the electronic system;
- (4) Notwithstanding anything contained in any law, where a declaration is submitted by electronic means, the declaration in such form shall have evidentiary value when it has been duly issued by the Commissioner."

Amendment of section 8

- 7. Section 8 of the principal Act is amended as follows
 - (a) by repealing paragraph (a) and substituting therefor the following
 - "(a) the name, surname, place of residence of the public person.";
 - (b) by repealing in each of paragraphs (e)(i), (e)(ii), (e)(iii),(e)(iv), (f) and (g) the words "or any member of his or her immediate family"; and
 - (c) by repealing in each of paragraphs (e)(v), and (e)(vi) the words "member of his or her immediate family,";

Repeal of Part IV

8. The principal Act is amended by repealing Part IV and sections 16, 17 and 18.

Substitution of section 19

9. The principal Act is amended by repealing section 19 and substituting therefor the following —

"Annual Report

19. The Commissioner shall, as soon as possible after the expiration of each calendar year and in any event not later than the 31st day of March in any year, make and submit to the President with a copy to the Speaker of the National Assembly and the Attorney General, a report on the exercise of the functions of the Commissioner under this Act during the preceding year."

Amendment to section 20

10. The principal Act is amended by repealing section 20(1) and substituting therefor the following —

"(1) The seal of the Commissioner shall be such device as may be determined by the Commissioner."

Transitional provisions

11. On the commencement of this Act, the Commissioner appointed under section 3 of the principal Act shall cease to be the Commissioner and shall vacate his or her office; and the Commissioner shall not be entitled to claim any compensation for the premature termination of the terms of his or her office or of any contract of service with the Commission;
