#### Citation

**1.** These regulations may be cited as Seychelles Ports Authority (Stevedoring and Terminal Charges) (Amendment of Schedule) Regulations, 2022.

#### **Amendment of Schedule**

2. The Schedule of S.I. 15 of 2008 is amended by, inserting the following items under the "Other terms and conditions" —

**"4.** Except for charges levied under tariff 2.1.1.1 and 2.2.1.1, 40% of all Terminal Handling Charges levied are payable to the Seychelles Ports Authority on all billings within 15 days from the end of the month to which it relates.

5. For charges levied under tariff 2.1.1.1 and tariff 2.2.1.1 the following are payable to the Seychelles Ports Authority within 15 days from the end of the month to which it relates —

a.	Tariff 2.1.1.1	SCR 1,600 per container of TEU
b.	Tariff 2.1.1.1	SCR 3,200 per container of FEU
c.	Tariff 2.2.1.1	SCR 102 per freight tonne

6. The charges levied under this Regulation shall be applicable in all areas conducting Stevedoring and Terminal Handling activities in the whole of the Port Victoria Limit."

**"4.** Except for charges levied under tariff 2.1.1.1 and 2.2.1.1, 40% of all Terminal Handling Charges levied are payable to the Seychelles Ports Authority on all billings within 15 days from the end of the month to which it relates.

5. For charges levied under tariff 2.1.1.1 and tariff 2.2.1.1 the following are payable to the Seychelles Ports Authority within 15 days from the end of the month to which it relates —

a.	Tariff 2.1.1.1	SCR 1,600 per container of TEU
b.	Tariff 2.1.1.1	SCR 3,200 per container of FEU
c.	Tariff 2.2.1.1	SCR 102 per freight tonne

6. The charges levied under this Regulation shall be applicable in all areas conducting Stevedoring and Terminal Handling activities in the whole of the Port Victoria Limit."
