#### **ANNOUNCEMENT:-**

This is an announcement pursuant to section 152(c) of the Criminal Procedure Code (“CPC”). The Property described herein namely; **USD350** (United States Dollars Three Fifty) was

seized as part of a search which was conducted on one Nigerian national namely; Olamilekan Adeyemi Bello (“Bello”) who had just arrived in the Seychelles on board Ethiopian Airlines ET879 on the 6<sup>th</sup> of May, 2022. Bello was questioned by the Immigration Department at the arrival lounge at the Seychelles International Airport and upon a search that was conducted in his bags a sum of USD1100 was found.

At the time of the search, the officers suspected that some of the notes as found were counterfeits. That Bello was issued with a notice of prohibited immigrant and deported on the same day. That all the notes were given to the FCIU for further formalities. That amongst the notes, the ones bearing serial numbers:
