# 2020 Development (Seychelles) Limited Debt Guarantee Order, 2023

In exercise of the powers conferred by section 28 of the Public Debt Management Act, the Minister responsible for financial matters makes the following order —

#### Citation

1. This Order may be cited as the 2020 Development (Seychelles) Limited Debt Guarantee Order, 2023.

#### Loan Agreement

2. The Minister responsible for financial matters has in accordance to section 14 of the Public Debt Management Act, guaranteed a loan on behalf of the 2020 Development (Seychelles) Limited, for the sum of SCR12,650,000.00 with Nouvobanq (SIMBC) under an agreement dated 25<sup>th</sup> November, 2022, the particulars of which as stated in paragraph 3.

#### Particulars

**3.** The particulars of the First Demand Guarantee Agreement referred to in paragraph 2 are as follows —

(a)	Amount of Guarantee:	Seychelles Rupees Twelve Million Six Hundred and Fifty Thousand Only (SCR12,650,000.00);
(b)	Terms of payment:	The loan shall be repaid at Seychelles Rupees Five Hundred and Sixty Thousand Six Hundred and Fifty-Five and Seventy-Five Cents Only (SCR560,655.72);
(c)	Name of Lender:	Nouvobanq (SIMBC);
