# **Environment Protection (Environmental Laboratories) Regulations, 2023**

In exercise of the powers conferred by Section 64 of the Environment Protection Act, 2016 the Minister responsible for the environment makes the following regulations —

#### Citation

1. These Regulations may be cited as the Environment Protection (Environmental Laboratories) Regulations, 2023.

#### Recognition of environmental laboratories

**2.** The environmental laboratories specified in the schedule are recognized as environmental laboratories under the Act.

#### Functions of environmental laboratories.

- **3.** The environmental laboratories recognized under the Act shall have the following functions
  - (a) the application of standardisation methods for sampling and analysis of various types of effluents and pollutants;
  - (b) the analysis of samples sent by the authorised officer under the Act:
  - (c) carrying out such other functions as may be entrusted by the Minister.
