2. The Construction Professionals Council Act, 2022, shall come into operation on the 4^{th} day of December 2023.

EXPLANATORY STATEMENT ON OBJECTS OF AND REASONS FOR THE BILL

The object of this Bill is —

- (a) to amend section 26 of the Political Parties (Registration and Regulation) Act by exempting, from business tax, moneys obtained from the Fund established pursuant to section 27 and moneys received by political parties in the form of donations, gifts and membership subscriptions; and
- (b) as a consequence of the amendment in the Political Parties (Registration and Regulation) Act, to amend the Business Tax Act.

A BILL

FOR

AN ACT TO AMEND THE POLITICAL PARTIES (REGISTRATION AND REGULATION) ACT, 1995 AND TO MAKE CONSEQUENTIAL AMENDMENTS TO THE BUSINESS TAX ACT.

ENACTED by the President and the National Assembly.

PART I - PRELIMINARY

Short title

1. This Act may be cited as the Political Parties (Registration and Regulation) (Amendment) Act, 2023.

PART II - AMENDMENT TO THE POLITICAL PARTIES (REGISTRATION AND REGULATION) ACT

Amendment of section 26

2. Section 26 of the Political Parties (Regulation and Registration Act), 1995 is repealed and substituted with the following —

"26. A political party registered pursuant to section 3 shall be exempt from tax insofar as —

- (a) pursuant to Section 24(4D), it relates to moneys received in the form of donations, gifts and membership subscriptions; and
- (b) it relates to moneys of the Fund established pursuant to section 27 of this Act."

PART III - CONSEQUENTIAL AMENDMENTS TO THE BUSINESS TAX ACT (CAP 20)

Amendment of section 15

3. Section 15 of the Business Tax Act, in this Part referred to as the "principal Act" is amended —

- (a) by deleting in subsection (1) the words "an amount is not allowed as a deduction if the amount" and replacing it with the words "For the purpose of determining what constitutes taxable income pursuant to section 10, the items in the following list shall be construed as non-deductibles"-; and
- (b) by inserting after paragraph (j) the following new paragraph
 - "(k) a gift or donation, given to a political party registered pursuant to the Political Parties Registration and Regulations) Act."

Amendment of Second Schedule

4. The Second Schedule to the principal Act is amended by inserting after item 24, the following new item -

"25. Income accruing to a political party registered under the Political Parties (Registration α and Regulation) Act obtained from —

- (a) the Political Parties Financial Support Fund established under Section 27 of the Political Parties (Registration and Regulation) Act;
- (b) donations;
- (c) gifts; and
- (d) membership subscriptions.".

REVENUE ADMINISTRATION (AMENDMENT) BILL, 2023

OBJECTS AND REASONS

The object of this Bill is to amend the Revenue Administration Act (Cap 308) in order to prescribe for electronic filings of documents through the Seychelles Revenue Commission's Tax Management System platform as one of the manners of lodging relevant documents and to provide for taxpayers to affix their signature to the record using either a wet signature or an electronic signature.

AN ACT TO AMEND THE REVENUE ADMINISTRATION ACT (CAP 308).

ENACTED by the President and the National Assembly.

Short title

1. This Act may be cited as the Revenue Administration (Amendment) Act, 2023.

Amendment of section 2

2. Section 2 of the principal Act is amended by inserting after the definition of "electronic record" the following definition —

"electronic signature" means a digital signature as prescribed under Section 3 of the Electronic Transactions Act, 2001, or an electronic id with an email, password and security pin; ".

Amendment of section 94

3. Section 94 of the Revenue Administration Act (Cap 308) in this Act referred to as the "principal Act" is amended by substituting the full stop after the word "Commission" for a comma and inserting thereafter the following words —

"or submitted electronically through the electronic service established by the Commissioner General.".

Insertion of section 94A

4. The principal Act is amended by inserting after section 94 the following section —

"Manner of signing documents

94A. An application, notice or other document referred to in section 94 shall be signed using either a wet signature or an electronic signature.".

Short title

1. This Act may be cited as the Appropriation Act, 2024.

Authorisation of expenditure

The Minister of Finance, National Planning and Trade, may by warrant under the hand of the Minister authorise the issue from the Consolidated Fund for the services of the Republic for the year 2024, of a sum not exceeding Ten billion, six hundred and forty million, and six hundred and twenty-eight thousand nine hundred and sixty-six (R10,640,628,966) which sum shall be appropriated in accordance with the Schedule for the purposes specified therein.
