# Stamp Duty (Exemption) (Amendment) (No.2) Order, 2023

In exercise of the powers conferred by section 47 of the Stamp Duty Act, the Minister responsible for finance makes the following Order —

#### Citation and Commencement

1. This Order may be cited as the Stamp Duty (Exemption) (Amendment) (No.2) Order,2023 and shall be deemed to have come into operation on the 29<sup>th</sup> May, 2023.

## Amendment of S.I. 51 of 2019 as amended by S.I 40 of 2023

- **2.** The Stamp Duty (Exemption) Order,2019 is amended as follows
  - (a) in paragraph 3
    - (i) by deleting in subparagraph (3)(a) the word "and";
    - (ii) by repealing subparagraph (3)(b) and substituting it with the following new subparagraph
      - "(b) the exemption for the transfer of matrimonial home or matrimonial property or any undivided share therein by one spouse to the other is limited to a consideration or a value of Seychelles rupees one million and five hundred thousand (SCR1,500,000.00) and;"
    - (iii) by inserting after subparagraph (3)(b) the following new subparagraph —

- "(c) the exemption for the transfer of matrimonial home or matrimonial property or undivided share therein by one spouse to the children of any or both of the spouses is limited to a consideration or value of Seychelles rupees three million (SCR 3,000,000.00)."
- (b) by inserting after paragraph 3, the following new paragraphs —

# "Exemption under the Sale of State Land and Land Bank Policy

- **3A**(1) Where an instrument in respect of a transfer of immovable property under the Sale of State Land and Land Bank Policy of the Government is chargeable with stamp duty and the transfer price is less than the market value of the land, stamp duty shall be chargeable on the transfer price stipulated in the instrument of transfer and the difference between the market value of the land and the transfer price shall be deemed exempted from stamp duty."
- (2) Order 3A(1) shall not be applicable where the instrument is exempted from stamp duty under any other order.

## African Development Bank Loan Agreement Debt Order, 2023

In the exercise of the powers conferred by section 28 of the Public Debt Management Act, the Minister responsible for financial matters makes the following order —

#### Citation

1. This Order may be cited as the African Development Bank Loan Agreement Debt Order, 2023.

## Loan Agreement

2. The Minister responsible for financial matters has in accordance with section 4 of the Public Debt Management Act, entered into a loan agreement with the African Development Bank ("the loan agreement") to assist in the financing of the Governance and Economic Support Programme Phase III to advance fiscal sustainability, improve the business environment and enhance climate change and environmental resilience.

#### **Particulars**

3. The particulars of the Loan Agreement referred to in paragraph 2 are as follows —

(a) Name of lender: African Development Bank;

(b) Name of borrower: Republic of Seychelles;

(c) Amount of the loan: USD 33,000,000 (United States

Dollars Thirty-Three Million only);

(d) Purpose of loan: To assist in the financing of the

Governance and Economic Support

Programme;

(e) Terms of payment:

Payable semi-annually on the 15<sup>th</sup> May and 15<sup>th</sup> November in 34 equal installments over a period of 17 years, after the expiration of a grace period of 8 years;

(f) Interest payable:

Interest is payable by the Borrower on the Disbursed Loan Balance, for each Interest Period shall be at a percentage rate per annum equal to the sum of the —

- (i) Floating Base Rate;
- (ii) Lending Margin;
- (iii) Funding Coast Margin; and
- (iv) Maturity Premium of twenty (20) basis point per annum provided, however, that if the interest is less than zero, the interest rate shall be deemed to be zero.

To be treated as financing;

# Licences (Trade) (Amendment) (No.2) Regulations, 2023

In Exercise of the powers conferred by section 28 of the Licences Act, (Cap 113) the Minister responsible for finance makes the following regulations —

#### Citation

1. These Regulations may be cited as the Licences (Trade) (Amendment) (No.2) Regulations, 2023.

## Amendment of regulation 2

- **2.** Regulation 2 of the Licences (Trade) Regulations, 1987 is amended by inserting immediately after subregulation (2), the following new subregulations
  - **"2A.**(1) The licence to trade shall require a licensee engaged in retail of the goods in the categories determined by the Authority to use an electronic cash register and a Point of Sale machine.
  - (2) For the purpose of subregulation (1), "Point of Sale machine" means an electronic device that allows customers to make payments to a merchant for goods and services by card, scanning or other electronic means and issues a transaction receipt.
  - **(2B).** Subregulation (2A) does not apply to a licensee operating a kiosk, tuck shop, snack shop, food van, a market vendor or street vendor."

#### PUBLIC DEBT MANAGEMENT ACT

(Cap 302)

# Public Finance Management (7th December Disaster Fund Bank Accounts) Regulations, 2023

In exercise of the powers conferred by section 36 (d) of the Public Finance Management Act, 2012 the Minister responsible for finance makes the following regulations —

#### Citation and commencement

1. These Regulations may be cited as the Public Finance Management (7<sup>th</sup> December Disaster Fund Bank Accounts) Regulations, 2023 and shall be deemed to have come into operation on the 7<sup>th</sup> December, 2023.

## **Special accounts**

- **2.**(1) The Minister shall open and operate the special accounts whose particulars are specified in the Schedule.
- (2) The special accounts shall receive financial support and process payments relating to the 7<sup>th</sup> December 2023 Disaster, and be used for such other purposes as the Minister may determine.
  - (3) The authorised signatories to the special accounts shall be
    - (a) Secretary of State Ministry of Finance, National Planning and Trade;
    - (b) Principal Secretary Finance Department;
    - (c) Comptroller General;
    - (d) Deputy Comptroller General; and
    - (e) Director of Public Budget Management.

(4) Payments out of the special accounts shall require at least two authorised signatories.

## Audit of accounts

3. The special accounts shall be audited by the office of the Auditor General.
